Notice Concerning the Change of Organization, Auditor and Important Employee at the Asset Management Company

United Urban Investment Corporation ("United Urban") hereby announces that the board of directors at Japan REIT Advisors Co., Ltd. ("JRA"), the asset management company to which United Urban entrusts asset management services, ratified the changes of organization and important employee at the general shareholders meeting today. In addition, the auditor will resign as set forth below.

1. Overview of the Changes

In JRA, the Chief Compliance Officer ("CCO") has been responsible for both directing and controlling compliance operations as well as directing and controlling internal audit operations, thereby overseeing the management system for compliance risks from a standpoint independent from divisions for business execution and other administration.

With an aim to further strengthen the system for risk management and internal control, JRA has decided to establish an independent organization to oversee the internal audit operations named as "Internal Audit Office" dated October 1, 2023. At the same time, CCO will exclusively specialize in the planning, promotion, and supervision of compliance.

With the new establishment of the Internal Audit Office, the auditor and CCO (an important employee) will be changed as the table below. For a career summary of CCO to be appointed and the organization chart as of October 1, 2023, please refer to the attachment.
